# Social Housing

Private sector with public sector limitations.... a challenging relationship

In the social housing sector, as in all public sectors, there are a lot of demands imposed on what information needs to be either collected / processed for it to then be shared with the requesting third party, usually being led by demands imposed by local / central government.

CORE - COntinuous REcording of data on social housing lettings and sales,

Working with MASH (Multi-Agency Safeguarding Hub )

Sharing data under MARAC (Multi-Agency Risk Assessment)

Sharing data under MAPA (Multi-agency public protection arrangements)

# Schools challenges

Within the schools that we are directly working with and from events we attend we are hearing some of the same constraints being echoed across the sector. These tend to be around the;

- Outsourcing of services (i.e: HR / Finance)?
- Health data?
- Data sharing?

Are you schools experiencing the same struggles?

# What should you do?

- Ensure you record your processing activity
- Privacy Notice
- Have a central data sharing agreement register
- Log your concerns and risks
- Open communications with the third parties
- Work with your peers, colleagues
- Ensure your ICT can support your compliance
- Ask the regulator

# To recap

Most of the time you will not have a choice, you will need to collect and share data as instructed. These are risks and should be managed as such.

- Record the processing activity on your data map
- Reference the processing activity on your Privacy Notice
- Record and store the data sharing agreement / instructions provided in your data sharing / processing depository
- Identify , register and evidence your concerns
- Do not be afraid to engage with the regulator / requesting body for guidance and support
- Log your risks
- Engage with internal peers to investigate possible options
- Investigate IT security related solutions to support the activity
- Inform the ICO of your concerns and be guided by their feedback

# Any Questions?

The DPA 18 / GDPR 16 are not in place to stop you from doing anything! They are in place to support you, help you establish foundations to ensure that what you do is undertaken in such a way to protect the rights and freedoms of those whose information you are processing.

When faced with those obstacles, Don't ever despair! Take a step back, and remember the purpose of Data Protection.


